**Petition No. OP 61 of 2019**

In the matter of : Approval of Power Purchase Agreement (PPA) for the enhancement of contract demand from 1000 kVA to 1400 kVA between KSEB Ltd and KPUPL in respect of KINFRA Integrated Industrial & Textile Park, Kanjikode, Palakkad.

Petitioner : KINESCO Power Utilities Private Limited (KPUPL)  
KINFRA Park office, Infopark P O, Kakkanadu, Kochi.

**Order dated 16.12.2019**

1. M/s KINESCO Power Utilities Private Limited (hereinafter referred to as the petitioner or KPUPL) has filed a petition before the Commission on 27.11.2019 seeking approval of the draft Power Purchase Agreement (PPA) for the enhancement of contract demand from 1000 kVA to 1400 kVA between KSEB Ltd and KPUPL in respect of KINFRA Integrated Industrial & Textile Park, Kanjikode, Palakkad.
2. The brief background of the petition is as follows;
  - (i) Kerala Industrial Infrastructure Development Corporation (KINFRA) is a statutory body formed by Kerala Government to develop, promote and maintain Industrial Infrastructure in the state of Kerala as per the provisions of the Kerala Industrial Infrastructure Development Act, 1993. KPUPL is a subsidiary company of KINFRA, established for distribution of electricity with in the industrial parks and special economic zones, developed by KINFRA. M/s KINESCO Power and Utilities Private Limited (KPUPL) is authorised to distribute electricity at KINFRA Integrated Industrial & Textile Park (KIITP) at Kanjikode, Palakkad.
  - (ii) KPUPL started operation at KIITP at Palakkad with effect from 05.08.2016. Initially, on 10.06.2016, KPUPL had entered into power purchase agreement (PPA) with KSEB Ltd for a contract demand of 500 kVA for meeting the load requirement at KIITP at Palakkad.  
  
Subsequently, vide the supplementary PPA 17.10.2018 to the original PPA dated 10.06.2016, KPUPL enhanced the contract demand from 500 kVA to 1000 kVA.
  - (iii) Now vide the petition dated 27.11.2019, M/s KPUPL submitted that the present power requirement at KIITP exceeded above 1000 kVA and

connection agreement was signed with KSEB Ltd for 1400 kVA on 27.05.2019.

Draft supplementary PPA for enhancing the contract demand from 1000 kVA to 1400 kVA was initialled by KPUPL and KSEB Ltd is also submitted along with the petition.

3. The Commission examined the petition filed by KPUPL along with the draft supplementary PPA to the original PPA dated 10.06.2016 and its amendment dated 17.10.2018, signed between KSEB Ltd and KPUPL for purchasing power from KSEB Ltd for distributing within the licensed area of KINFRA Integrated Industrial & Textile park at Kanjikode, Palakkad.
4. The present petition is for entering into a supplementary PPA with KSEB Ltd for enhancing the contract demand from 1000 kVA to 1400 kVA. Accordingly, the Commission approves the following amendments in the PPA dated 10.06.2016 and supplementary PPA dated 17.10.2018.
  - (1) The Article 3.2 of the supplementary PPA dated 17.10.2018 shall be modified as;  
*“ KSEB Ltd shall supply to KPUPL at the point of supply at Palakkad and KPUPL shall take from KSEB Ltd power upto a total quantity of 1400 kVA at 22 kV at KINFRA Integrated Industrial & Textile Park at Kanjikode, Palakkad for its own use and for the purpose of supply to the consumers within the area of supply as provided in the license for distribution of electricity”.*
  - (2) In Schedule II A, the 4<sup>th</sup> row is amended as “Maximum Electrical Power required by KPUPL (Contract Demand) **1400 kVA at 22,000 Volts**”.
  - (3) All other terms and conditions specified in the Articles of PPA entered by the KSEB Ltd and KPUPL dated 10.06.2016 and its amendment dated 17.10.2018, shall hold good in the supplementary PPA to be executed for enhancing the contract demand from 1000 kVA to 1400 kVA at 22000 Volts at KINFRA Integrated Industrial & Textile park at Kanjikode, Palakkad.

A copy of the signed supplementary PPA entered into between the parties shall be submitted to the Commission for approval.

The petition disposed of accordingly.
