The Kerala State Electricity Regulatory Commission invites EXPRESSION OF INTEREST from reputed architectural firms for the following job.

1.0 Scope

- 1.1 Preparation of a Master Plan, Architectural and Engineering Designs of the following.
 - (a)Office building complex/services for Kerala State Electricity Regulatory Commission with a built up area of 2300 sq.m. (approximate) adopting green/eco-friendly building concepts. The building proposed is a four storeyed building and the facilities planned in each floor is given as Annexure-I. The office building complex is to be developed in an area of about 75 Cents of land in re-survey No.13 (Block-20) in Cheruvakkal Village of Thiruvananthapuram Taluk near Sreekaryam.
 - (b) Office building complex/ services for an approximate built up area of 800 sqm. adopting green/ eco-friendly building concepts. The building proposed is a three storeyed building and the facilities required in each floor is given as Annexure II. The office building complex is to be developed in an area of about 30 cents of land in Block 6, Re-survey No. 118 of Thrikkakara (N) village in Kanayannur Taluk, Ernakulam District.
- 1.2 The master plan shall be of such standard that, they are befitting an office complex with modern facilities.
- 1.3 Preparation of all inputs and obtaining necessary approvals of various statutory authorities, for the Master Plan as well as the building complex/facilities.
- 1.4 Drawing up specifications, preparing detailed cost of estimates including analysis of rates for different items at prevailing PWD rates for the entire works, and preparing the tender documents as per the requirements of KSERC.

2.0 Eligibility

2.1 Those firms who have successfully carrying out the planning of three works of similar nature, each costing not less than 4 crores or two works of similar nature, each costing not less than 6 crores or one work of similar nature costing not less than Rs. 8 crores during the last seven years ending last day of December 2015 only need to respond/submit their Expression of Interest. The details of experience in carrying out the works in Proforma given as Annexure II

and staff strength available in house etc., shall be submitted along with the Expression of Interest.

3.00 Selection Procedure

- 3.1 Tender documents/Request for Proposal shall be issued only to short listed firms.
- 3.2 Short listed firms will be required to give a presentation of the preliminary proposals (based on which detailed designs are to be finalized subsequently) to an expert committee constituted by the Kerala State Electricity Regulatory Commission, Thiruvananthapuram.
- 3.3 Selected firm should be ready to undertake the work to a tight time schedule as per the requirement of Kerala State Electricity Regulatory Commission, with a time bound programme as approved by Kerala State Electricity Regulatory Commission.
- 3.4 Short listing and final selection of the firm will be done by a duly constituted Committee and the decision of Kerala State Electricity Regulatory Commission will be final and binding in this respect.
- 4.0 The Expression of Interest shall be submitted in sealed envelope superscribing the words "Expression of Interest" and shall reach the office of the undersigned on or before 5.00 p.m., 28.02.2016.
