Sub: KSERC - Filling up of the post of Electricity Ombudsman -applications invited.

Applications are invited by the Kerala State Electricity Regulatory Commission for filling up the post of **Electricity Ombudsman**. Candidates should be an electrical engineer of ability, integrity and standing who has experience of not less than 20 years in power sector. Knowledge in management, finance or law is an additional qualification. The person shall have working knowledge of Malayalam.

The term of appointment shall be for a period of three years, which may be extended for a further period of two years subject to an overall age limit of 65 years.

The Headquarters of the Ombudsman shall be at Kochi.

The remuneration and allowance payable to the Ombudsman and the service conditions shall be governed by the provisions in the Kerala Electricity Ombudsman (Terms and Conditions of Service) Regulations, 2008 and its amendment dated 11/8/2011; which are available in the website of the Commission.

Application on plain paper with bio-data and details of experience superscribing the envelope "Application for the post of the Electricity Ombudsman" should reach the Secretary, Kerala State Electricity Regulatory Commission, KPFC Bhavanam, C.V. Raman Pillai Road, Vellayambalam, Thiruvananthapuram – 695010 on or before **21/2/2014.**

Those who are now working in State/Central Government, PSUs, autonomous bodies etc, shall submit their application through the proper channel with an advance copy to the Secretary, Kerala State Electricity Regulatory Commission so as to reach him in the above address on or before 21/2/2014. Applications submitted otherwise and belated applications will not be considered in any case.

In exercise of the powers conferred under Sub-section (6) of Section 42 and Sub-section (1) of Section 181 of the Electricity Act, 2003 (Central Act 36 of 2003) the Kerala State Electricity Regulatory Commission hereby makes the following Regulations, namely:-

CHAPTER I

GENERAL

- Short title and Commencement.- (1) These Regulations may be called the Kerala Electricity Ombudsman (Terms and Conditions of Service) Regulations, 2008.
 - (2) They shall come into force from the date of their publication in the Kerala Gazette.
- **2. Definitions.-**(1) Unless there is anything repugnant to the subject or context;
- (a) 'Act' means the Electricity Act, 2003.
- (b) 'Commission' means Kerala State Electricity Regulatory Commission
- (c) 'Chairperson' means Chairperson of the Commission
- (d) 'Member' means Member of the Commission.
- (e) 'Ombudsman' means the person appointed by the Commission under Section 42(6) of the Electricity Act;
- (f) 'Year' means calendar year;
- (2) Words or expressions used in these Regulations, but not defined, unless the context otherwise requires shall have the same meanings as are respectively assigned to them in the Act or in the fundamental and supplementary rules as are adopted or made applicable to the Officers/Employees of the State Government.

CHAPTER II

APPOINTMENT

3. Strength. - (1) The officers and supporting staff of the Ombudsman are categorized as under and the strength of each category is as follows:

Staff

Confidential Assistant : 1 No.

Attender : 1 No.

- (2) The approval of the staff strength indicated above shall also be treated as approval for creation of posts.
- **4. Appointments. -** (1) All appointments shall be made by the Commission.
- (2) The qualification and experience required for each post shall be as laid down in Annexure I, provided that the Commission reserves the right to relax the eligibility criteria in suitable cases, for reasons to be recorded in writing.
- (3) The supporting staff of the Ombudsman shall be appointed on deputation from State Government employees on usual terms and conditions of deputation under Kerala Government Service Rules.
- **5. Pay and Allowances of Supporting Staff** . (1) The pay scales for the supporting staff of the Ombudsman shall be as furnished in Annexure II and they shall be entitled to DA, as admissible to the employees of the Government of Kerala.
- (2) The House Rent Allowance and City compensatory Allowance will be paid to the staff attached to the Ombudsman at the rates as may be determined by the Commission from time to time.
- (3) Staff joining on deputation shall be eligible for deputation allowance as admissible under the Rules of their parent department.
- (4) The officers and staff shall subscribe to the General Provident Fund in accordance with the relevant Rules.

CHAPTER III

OMBUDSMAN

- **6. Appointment of Ombudsman.-** (1) The Commission shall appoint a person as Ombudsman as provided in the Act.
- (2) The Selection Committee for Ombudsman shall consist of Chairperson and Members of the Commission. The Chairperson of the Commission shall be the Chairperson of the Selection Committee. The Commission may include external expert/experts in the Selection Committee.
- **7. Tenure of Appointment. -** The Ombudsman shall be appointed for a term not exceeding three years. Provided that the tenure of the Ombudsman may be extended by the Commission for a further period not exceeding two (2) years subject to an overall age limit of sixty five (65) years.
- **8. Removal from Office.** (1) The Ombudsman shall not be removed from Office except in accordance under these Regulations.
- (2) The Commission, may by order, remove from Office, the Ombudsman, if he
 - i. having been adjudged as insolvent;
 - ii. having been convicted of an offence involving moral turpitude;
 - iii. having become physically or mentally or otherwise incapable of acting as an Ombudsman;
 - iv. having acquired such financial or other interest as is likely to affect prejudicially his function as an Ombudsman;
 - v. having abused his position as to render his continuance in office prejudicial to public interest;
 - vi. having been guilty of proved misbehaviour:
 - vii. having become a member of political party;
- **9. Working hours.-** (1) The Office of the Ombudsman shall be open daily except on second Saturdays, Sundays and holidays notified by the Government of Kerala. The office of the Ombudsman shall be open at such other times as the Commission may direct. The working hours of the Ombudsman shall be from 10.00 hours to 17.00 hours. The lunch break shall be from 13.00 hours to 13.30 hours.
- (2) Where the last day for doing of any act falls on a day on which the office of the Ombudsman is closed and by reasons thereof the act cannot be done on that day, it may be done on the next working day on which the office is open.

- **10.** Pay & Allowances of Ombudsman.- (1) Remuneration and other allowances payable to the Ombudsman shall be such as may be specified with the approval of the Government. The Ombudsman shall be entitled to a consolidated remuneration of Rs.30,000/- (Rupees Thirty Thousand only) including all benefits such as DA, HRA and CCA less pension.
- (2) Conveyance facility shall be provided to the Ombudsman for discharging official duty.
- **11. Powers and Duties of the Ombudsman. -** The powers and duties of the Ombudsman shall be as specified under Section 19 of the Kerala State Electricity Regulatory Commission (Consumer Grievance Redressal Forum and Electricity Ombudsman) Regulations, 2005.

CHAPTER IV

MISCELLANEOUS

- **12. Power to remove difficulties.** If any difficulty arises in giving effect to any of the provisions of this Regulation, the Commission may by general or special order, take appropriate action, not being inconsistent with the Electricity Act, 2003, which appears to the Commission to be necessary or expedient for the purpose of removing such difficulties.
- **13. Power to amend. -** The Commission may, at any time add, modify, delete or amend any of the provisions of this Regulation subject to the provision of The Electricity Act, 2003.
- **14. Submission and publication of Reports by the Ombudsman. -** The Electricity Ombudsman shall comply with the requirements regarding submission and publication of reports as specified under Section 28 of the Kerala State Electricity Regulatory Commission (Consumer Grievance Redressal Forum and Electricity Ombudsman) Regulations, 2005.

In exercise of the powers conferred by Section 181 of the Electricity Act, 2003 (Central Act 36 of 2003), and after previous publication, the Kerala State Electricity Regulatory Commission hereby makes the following Regulations to amend the Kerala Electricity Ombudsman (Terms and Conditions of Service) Regulations, 2008, published as Notification No. 1/1/KSERC/2008 dated 21st May, 2008 in Kerala Gazette Extraordinary No. 1035 dated 24th May, 2008, namely:-

- 1. Short title and commencement.- (1) These Regulations may be called the Kerala Electricity Ombudsman (Terms and Conditions of Service) Amendment Regulations, 2011.
 - (2) They shall come into force at once.
- 2. Amendment of Regulations.- In the Kerala Electricity Ombudsman (Terms and Conditions of service) Regulations, 2008,
 - i. in regulation 3, below the word "staff", the following words shall be inserted, namely:-

"Secretary: 1 No.";

- ii. in regulation 10, the second sentence beginning with "The Ombudsman" shall be deleted.
- iii. in Annexure I, -
 - (a) for the existing heading "Qualifications for the post of Confidential Assistant and Attender", the following heading shall be substituted, namely:-

"Qualifications for the post of Secretary, Confidential Assistant and Attender":

(b) the existing SI.No. shall be renumbered as SI.No.2 and 3 and before SI.No.2 as renumbered, the following SI.No. and corresponding entries shall be inserted namely:-

"1.Secretary

- (i) Degree from a recognised University
- (ii) Proficiency in Computer MS Office
- (iii) Minimum 2 years experience in office Administration.

Note: Graduation in Law will be treated as an additional qualification".

- iv. in Annexure II,-
 - (a) the existing SI.Nos. shall be renumbered as SI. No. 2 and 3 and before SI.No.2 as renumbered, the following SI. No. and corresponding entries shall be inserted, namely:-
 - "1. Secretary Rs. 9190-200-9590-240-10790-280-11910-340-13610-380-

15510";

(b) the following Note shall be added at the end, namely:-

"Note: Whenever the above scale of pay is revised by Government by Pay revision or otherwise, such revision shall be applicable to these posts also".

(Explanatory Note)

The monthly remuneration of Ombudsman fixed as per the existing Regulations is Rs. 30,000/- less pension. This amount is considered very small when compared to the status and work of the Ombudsman. Government accorded sanction for refixing the monthly remuneration of Ombudsman as Rs. 30,000/- (Rupees Thirty Thousand only) excluding pension, as per Go(Rt) No.12/11/PD dated 13.01.2011. Therefore the Commission has decided to fix Ombudsman's remuneration as Rs. 30,000/- per month without reducing the pension if any that the Ombudsman receives.

Also Government have sanctioned one post of Secretary in the office of Ombudsman as per G.O.(MS) No.28/2010/PD dared 19.11.2010. Therefore this post has also to be included in the Regulation.

This notification is intended to achieve the above object.
